- Location** The Show is held at Trengrove Farm, Merrymeet, Liskeard.
- Applications** Applications should be received by 14th June 2008 and will be dealt with on a first come first served basis. Fees to be paid in full prior to the show day. No stands will be allowed on site until full payment has been received. Stamped addressed envelope with application please. If you require confirmation of your booking enclose two SAEs.
- Cost** Small Stand (2 metres wide) £20.00, to include 1 table (1.8m length)  
Large Stand (4 metres wide) £35.00, to include 2 tables.
- Cancellations** A full refund will be made if the stand is cancelled before 14th June 2008.  
50% will be refunded if the stand is cancelled between 15th June and 7th July 2008.  
No refund will be given for any stands cancelled after this. Refunds will be made after the show.
- Insurances** All traders must have adequate insurance cover valid at the time of the show and, if necessary, products and employer liability.
- Catering Rights** Food sold in the Cornish Food Marquee must not be for consumption at the show.
- Setting up** All stands must be set up by 9am and exhibitors are expected to keep stands open until the close of the show at approximately 5pm.
- Removal** All stands must be removed on the Saturday evening, as the marquee is taken down very early on the Sunday morning.
- Passes** 1 car pass and 2 exhibitor's passes will be issued for each Small Stand. Large Stands will receive an extra Exhibitor Pass. There will be no extra free tickets given out to exhibitors. Please budget your stand accordingly. If you require any additional tickets these may either be included when you book your stand (cost £6 each) or purchased on the gate.
- Electricity** Cost £10 per point, including the cost of the electricity. A separate form indicating requirements must be filled in. (Obtainable from [www.liskeardshow.org/ref/115608.htm](http://www.liskeardshow.org/ref/115608.htm)) or the secretary.
- Chairs** No chairs are provided.
- Tickets etc.** Receipt, details of site allocated, admission tickets and plan of showground will be sent to you by the end of June 2008.
- Safety Policy** A copy of our safety policy will be sent with your tickets.
- Barbecues** No barbecues are allowed on site except by prior arrangement.
- Fundraising** Please declare on your entry form if you intend to sell raffle tickets and/or collect donations at the show. You are reminded this must be done within the space of your stand area. The Association prefers that all stands should have goods to sell, not just run a raffle or collect donations.
- Generators** Generators and electrical equipment brought on site must be tested and certified by a competent person.
- Noise** Please state on the entry form if you intend to use any noisy equipment on your stand.
